3. I understand and agree that by admitting my dog(s) to WIGGLY TAILS, INC., there are certain risks inherent with a cage free environment that include, but are not limited to, injury and illness from interactions with other dogs and that Wiggly Tails, Inc., their staff, as well as their volunteers will not be liable for any injuries or harm caused to or by my dog(s) and that I will assume full financial and legal responsibility for any injuries or illnesses that my dog(s) sustains provided reasonable care and precautions have been followed by Wiggly Tails, Inc., their staff and volunteers.
4. I understand and agree that WIGGLY TAILS, INC., their staff, as well as volunteers will not be liable for any injuries or damages to my dog(s) arising out of or from the boarding and care of my dog(s) including loss by fire, theft, runaway, injury, or death while under the care of WIGGLY TAILS, INC. provided that reasonable care and precautions are followed and I hereby release them of any liability of any kind whatsoever arising from my dog's attendance at WIGGLY TAILS, INC.
5. I understand and agree that any problems that develop with my dog(s) will be treated as deemed best by the staff of WIGGLY TAILS, INC., at their sole discretion, and that I will assume full financial responsibility for any and all expenses involved.
6. I agree to indemnify, defend and hold harmless WIGGLY TAILS, INC., from any injury or harm of any kind whatsoever to third parties.
7. I agree to pay for all services that Wiggly Tails Inc. provides to my dog and me at the time of service completion.
8. Hours of operation for Daycare: M-F: 7 am-12 pm & 2-6:30 pm. I understand that Wiggly Tails' staff goes off duty at 6:30pm and that any pick up past 6:30pm will be charged a \$10 late fee up until 6:45pm.
9. I understand and agree that if my dog is not picked up from daycare before 6:45pm, he/she will be boarded and I will pay both the daycare and overnight fee upon pick up of my dog. A late fee charge may also be assessed at the sole discretion of Wiggly Tails, Inc.
10. Pick up & Drop off times for Boarding: M-F: 7 am-12 pm & 2-6:30 pm  
Saturday: 9 am-10 am & 4 pm-5 pm (by appt. only)  
Sunday: 9 am-10 am (by appt. only)  
Holidays: Closed
11. I understand that Wiggly Tails, Inc. charges a holiday/peak time surcharge for boarding stays. This surcharge is in effect around all major holidays and/or peak travel times including but not limited to "Spring Break," Memorial Day, Labor Day, Independence Day, Thanksgiving, Christmas, & New Year's.
12. I understand and agree that Wiggly Tails Inc. reserves the right to change prices, fees, and hours of operation without prior notice.
